**ACKNOWLEDGING that;**

1. NGC is a Degree level provincialized educational institution, having its address as Haibargaon, Nagaon, India, 782002.
2. RC is a Degree level provincialized educational institution, having its address as Rupahi, Nagaon, Assam 782125

**DESIRING to;** support the cooperation between the Parties in education and research programs;

**PURSUANT to** the prevailing laws and regulations, policies and procedures that govern the provincialized colleges in the state of Assam.

**HAVE REACHED** the following understanding: -

**ARTICLE 1  
OBJECTIVE OF COOPERATION**

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest.

**ARTICLE 2  
SCOPE OF COOPERATION**

The Parties agree to implement cooperation programmes including but not limited to:

- a. Faculty and student exchange
- b. Curriculum development of certificate and diploma courses
- c. Cooperation during conduct of student study tours
- d. Undertaking joint research at the faculty level
- e. Any other areas as mutually agreed upon by the Parties

**ARTICLE 3  
LOCATION OF ACTIVITIES**

1. The Parties agree to implement the programmes stated in ARTICLE 2 at NGC and RC.
2. Any changes to the location of the programmes shall be mutually agreed upon by the Parties

1. NGC appoints the Coordinator, IQAC, NGC (hereinafter referred to as NGC Rep).
2. RC appoints the Coordinator, IQAC, RC (hereinafter referred to as RC Rep).

**ARTICLE 5  
FINANCIAL ARRANGEMENT**

1. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

**ARTICLE 6  
INTELLECTUAL PROPERTY RIGHTS**

1. Each Party shall protect, within its capacity and territory, intellectual property rights of the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.
2. In case of specific arrangement, programmes or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

**ENTRY INTO FORCE, DURATION AND TERMINATION**



1. This MOU shall enter into force on the date of signing.
