**ON CAPACITY BUILDING, TRAINING & ACADEMIC COOPERATION**


Nowgong Girls' College, Haibargaon, Nagaon, Assam, hereinafter referred to as 'NGC' and Ashoka IAS Academy, Nagaon, Assam, hereinafter referred to as 'AIA', hereinafter individually referred to as 'the Party' and jointly referred to as 'the Parties';

**DESIRING** to support cooperation between the Parties in capacity building through seminar, workshop, coaching, training and other scholastic as well as co-scholastic activities;

**HAVE REACHED** the following understanding: -

1. The Parties will implement collaborative programmes including orientation for competitive examination, career counseling, student support programme, coaching for civil service, SSC, Bank PO, NDA, TET, NET and other capacity building initiatives.
2. Any specific activity of joint interest will be detailed separately including financial and programme specific arrangements.
3. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
4. In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.
5. The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage in those specific activities only with respect to laws and regulations in the state of Assam and the country of India.
6. Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between the Parties.
7. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall come into force on the date as may be determined by the Parties.

9. Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU one (1) month prior to the date of the termination.


10. The termination of this MOU shall not affect the completion of any programme, activity or project in progress and not completed at the time of termination.
