



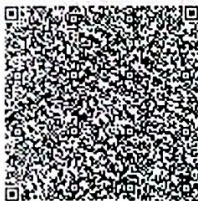

**MEMORANDUM OF UNDERSTANDING BETWEEN**  
**NOWGONG GIRLS' COLLEGE, NAGAON, ASSAM, INDIA**  
**AND**  
**CONCEPT SENIOR SECONDARY SCHOOL, NAGAON, ASSAM**  
**FOR ACADEMIC MENTORING AND CO-CURRICULAR**  
**ACTIVITIES**

Nowgong Girls' College, Haibargaon, Nagaon, Assam, hereinafter referred to as "NGC" and Concept Senior Secondary School Nagaon, Assam, hereinafter referred to as "CSSS", hereinafter individually referred to as "the Party" and jointly referred to as "the Parties".

ACKNOWLEDGING that;

1. NGC is a Degree level provincialized educational institution, having its address as Haibargaon, Nagaon, India, 782002.
2. CSSS, is a Senior Secondary level educational institution, having its address as Haibargaon, Nagaon, India, 782002.

DESIRING to: support the cooperation between the Parties in academic and co-curricular activities.

PURSUANT to the prevailing laws and regulations, policies and procedures that govern educational institutes in the state of Assam.

HAVE REACHED the following understanding :

**ARTICLE 1**  
**OBJECTIVE OF COOPERATION**

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational and co-curricular projects in areas of mutual interest.

**ARTICLE 2**  
**SCOPE OF COOPERATION**

The Parties agree to implement cooperation programmes including but not limited to :

- a. Student exchange.

- b. Cooperation during conduct of student study tours.
- c. Conducting co-curricular activities among the students.
- d. Providing infrastructural facilities to the students including laboratory facilities available in NGC.
- e. Any other areas as mutually agreed upon by the parties.

### **ARTICLE 3**

#### **LOCATION OF ACTIVITIES**

1. The Parties agree to implement the programmes stated in ARTICLE 2 at NGC and deliver lectures, organise seminars and career oriented programmes.
2. Any changes to the location of the programmes shall be mutually agreed upon by the Parties.

### **ARTICLE 4**

#### **EXECUTING AGENCIES**

To implement this MOU :

1. NGC appoints the Coordinator, IQAC, NGC (hereinafter referred to as NGC Rep.)
2. CSSS appoints Mr. Bhabananda Bora (hereinafter referred to as CSSS Rep.)

### **ARTICLE 5**

#### **FINANCIAL ARRANGEMENT**

1. Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.
2. Any specific project of joint interest will be detailed in a separate agreement, including financial and programme specific arrangements.

### **ARTICLE 6**

#### **INTELLECTUAL PROPERTY RIGHTS**

1. Each Party shall protect, within its capacity and territory, intellectual property rights of

the other Party in accordance with the laws and regulations in force in the state of Assam and the country of India.

2. In case of specific arrangement, programmes or projects that may result in intellectual property, the Parties shall conclude separate arrangement in accordance with the prevalent laws and regulations in the state of Assam and the country of India.

## **ARTICLE 7 CONFIDENTIALITY**

In the event that either Party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MOU, the disclosing Party shall have prior written consent of the other Party.

## **ARTICLE 8 LIMITATION OF PERSONAL ACTIVITIES**

The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage only in activities under the framework of this MOU with respect to laws and regulations in the state of Assam and the country of India.

## **ARTICLE 9 SETTLEMENT OF DISPUTES**

Any dispute concerning the interpretation and/or application of this MOU shall be settled amicably through consultation or negotiation between Parties.

## **ARTICLE 10 AMENDMENT**

1. This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
2. Such amendment or revision shall come into force on the date as may be determined by the Parties.

**ARTICLE 11**  
**ENTRY INTO FORCE, DURATION AND TERMINATION**

1. This MOU shall enter into force on the date of signing.
2. This MOU shall remain in force for a period of five (5) years and may be extended for another period of five (5) years by mutual consent of the Parties.
3. Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, six (6) months prior to the date of the termination.
4. The termination of this MOU shall not affect the completion of any programmes or projects in progress and not completed at the time of termination.
