

Sub.: Permission for opening of TDC Ist Year (Science Stream) General Course from the session 2017-18.

DECISION OF THE EXECUTIVE COUNCIL :

RESOLVED that the College be granted permission for opening of TDC Ist Year (Science Stream) General Course from the session 2017-18 with the following conditions:

1. The College authority should take immediate steps to recruit at least four teachers in each of the subject of Chemistry, Physics, Botany, Zoology and augment the existing teaching staff in Mathematics and Statistics.
2. The College is required to make an annual budgetary allocation exclusively to sustain the Science stream.
3. The College should procure adequate equipments, reagents etc. for practical courses as well as project work.
4. Each department should have separate library for Major students and the Central Library must be strengthened by including recent books in the subjects. It is also recommended that the department should subscribed to two or three Indian journals which might be of help in offering project as well as Literature survey work which is in the TDC Course.
5. The Principal should submit a compliance report within one month for further processing of the matter.
6. Intake capacity-120 (One hundred twenty).
